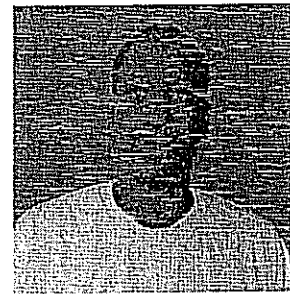

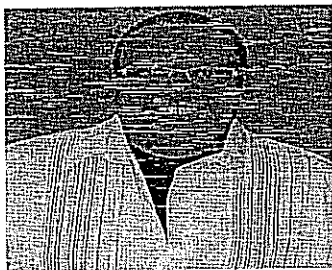


Erica Jackson-Current Briggs Trustee and former Steward of Dept. 797. Women of Steel Member, Chair of Human and Civil Rights Committee.

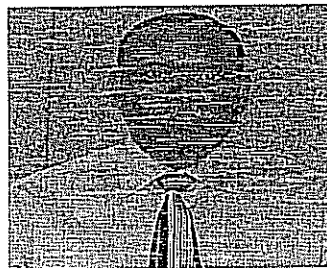


Travis Clark-Current Steward in Dept. 472.

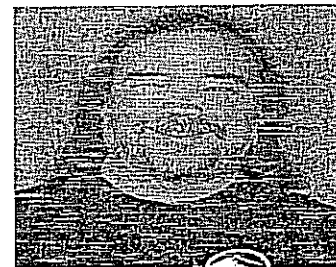

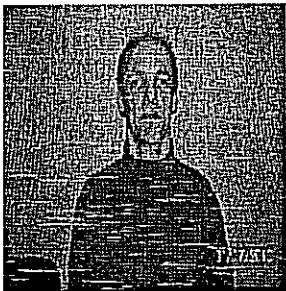

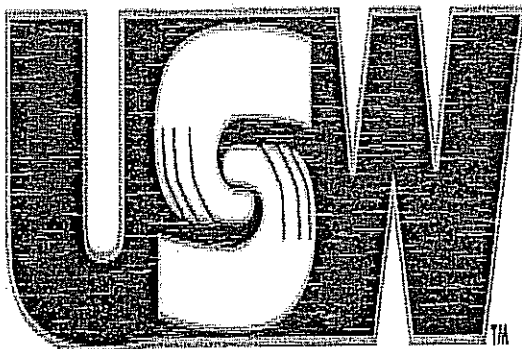
