The President's Report: Briggs Unit ratifies contract

On October 21, 2010, members at Briggs voted 211 to 77 to accept the successor contract proposal from Briggs & Stratton Corporation. The negotiation process had begun on June 30, 2010. This contract passed with no recommendation from the Bargaining Committee. The contract will be in effect through July 31, 2013. We were able to keep the 10 years of fully paid Insurance for members with 1979 seniority or greater until January 1, 2012. If you retire on or after January 1, 2012, you will have 5 years of Medical Insurance only.

- Their will be two (2) programs of Medical Benefits available, a Standard PPO plan and a
 High Deductible PPO plan. The EPO plan will be eliminated on December 31, 2010.
 The Standard PPO plan pays 80% in net work and the High Deductible PPO plan pays
 95% in net work after you pay your Annual deductibles.
- There will be a 2 % wage increase on August 1st, each year of the 3-year contract.
- This year's wage increase is retroactive to August 1, 2010.
- The life and accidental death insurance benefit will increase to \$30,000 on January 1, 2011, and increase to \$33,000 on January 1, 2012.
- The weekly disability rate was increase to \$365.00 per week upon ratification.
- You still have the \$25,000 lump sum pension payment for those that are eligible.
- You have the lump sum supplemental benefit of \$1,000 until January 1, 2013.
- The members received a \$500.00 ratification bonus.

Union Dues

In regards to the union dues deduction process changes. When PACE International Union Merged with the United Steel Workers International Union in 2005 part of the agreement was the former PACE members would not pay union dues under the USW dues process until January 1, 2011. That's why these changes will be taking place in January. A special meeting was held on November 14, 2010, to explain the union dues deduction process.

Executive Board / Election

At the October 17, 2010, Membership Meeting, elections were held; Vinith Inthisane was elected Briggs Trustee, Yolanda Turner was elected Trustee At Large, and Gloria Smith was elected for the Guide position.

• Due to the resignation of Tameka Smith, the Recording Secretary position is open. There will be an election to fill this position at the January 16, 2011, membership meeting.

Open Enrollment at Briggs

Open enrollment at Briggs was November 16, 2010 through November 30, 2010. A Confirmation Statement will be sent to you. Review your statement and make sure it reflects the benefit elections and changes you made.

At Strattec

At the October 17, 2010, Membership Meeting, Diane Neely was elected Strattec Grievance Representative. She will finish out the term of Milton Dawson who resigned in June. Strattec paid out a 12.16% EVA Bonus in August. The Company stated they had a good year and the first half of this year looks good. They have hired new employees to help meet the business demand.

Open Enrollment at Strattec

The open enrollment period at Strattec is November 15th through December 15, 2010. If you are not making any changes, you don't have to do anything. However if you have a Flexible Spending Account you need to sign up again. Under Health Care Reform, your dependents can remain on your Insurance until the age of 26.

Three/Discharged

Three (3) members were discharged and after meeting with the Company during 3rd stage grievance meetings two (2) were reinstated, one at Briggs and one at Strattec. We currently have a 3rd stage grievance meeting scheduled with Briggs for December 15, 2010.
