Strattec Membership Ratifies Contract

At Strattec, the new contract was overwhelmingly ratified on June 22nd. The vote was 138 to 13. And as usual we are having some interpretation issues following this negotiation. We are dealing with this and may have to sit down with Strattec to reiterate exactly what was discussed across the table. We also have received the contract itself so we can proof-read it and have it printed up. I know in 2005, the committee had to go through it several times until it was finally right and sent to print.

BRIGGS

At Briggs the 100th anniversary celebration was held on Sunday August 3, 2008 at the zoo. I would like to say congratulations to Briggs & Stratton and I also would like to say; thanks to the work ethic of this union membership over the years that has certainly contributed to the success of Briggs & Stratton.

Approximately 50 some members retired on July 1st as several did cancel their retirement. There were retirement meetings held by Mercer and benefits on Thursday July 31st at Burleigh and August 7th at the Falls. Any member that wanted to sign up to retire on January 1st was able to fill out their Intent to retire form right there at the meeting.

Survivor Options

If you are 55 years of age and have 10 years of seniority or have 29 years and 1000 hours you are eligible to sign up for a pre-retirement election for a survivor option at Briggs or Strattec. In 2005 at Briggs the penalty for changing was eliminated and at the negotiations at Strattec this year, we were also successful at having the penalty eliminated so at this point there is no reason not to sign up for 100% for your spouse. You can change your option when you retire without penalty. In the past, you were charged a percentage per year that the option was in effect.

Jesse, Ralph and I attended the USW Convention. The message was clear that Obama is the choice for working people. We were hoping that Obama would have been at the convention live. Well we partially got that wish. John Edwards was live at the convention and he introduced Senator Obama, who was live via satellite. He could hear and see us and we obviously could hear and see him. The place was truly rockin'. We need to do everything we can to help working people by helping Senator Barack Obama get elected as the next President of the USA.

We cannot afford to have any more time of Bush economics, as it will be if McCain gets elected.

CHANGING JOBS AFTER A WORK INJURY

Many employees find themselves changing employers after a worker's compensation injury. If you worked for an employer for several years and did not seriously pursue your worker's compensation injury case while working for that employer, the time to quantify the injury is at the end of that employment before you go on to another employer.

At the end of employment with your old employer, make sure your doctor clearly states what your complaints are and if you have any permanent disability. The reason for this is that if you have further problems with your injury, the new employer is going to attribute them to your old employment. Likewise, the old employer is going to attribute them to your new employment. You may very well be caught in the middle no matter what, but you can help minimize your situation by making sure that your symptoms from the first employment have been quantified before going on to the next employment.

Employees who are in the trades and who have many different employers over a short span of time must pay close attention to how each employment affects the symptoms of work related injuries. Report them accurately to your doctor including the periods of time and what you were doing for each employer. This is the only way to protect yourself against inevitable controversy over liability for your claim among the various worker's compensation carriers for your numerous employers.

Rapid Response Coordinator

Dear Brothers and Sisters;

The Rapid Response program is a very important part of our activist union. It keeps our members informed and helps them to become involved in important issues that affect our daily lives. Rapid Response gives our members a voice and is a powerful tool in shaping policies to benefit workers rather than corporate interests.

Your Rapid Response Team is in the process of attempting to stop the Columbia Free Trade Agreement. This agreement has not only generated policies which have cost our country millions of manufacturing jobs, boosted trade deficits to record levels and shredded the paychecks of U.S. workers; it has lead to the loss of many innocent lives. Thanks to your efforts, we have been able to generate 8,100 letters, signatures and phone calls to aid in our attempt to stop the approval and passing of this agreement. In regards to the Employee Free Choice Act, we have generated 7,900 signatures and will continue to pursue this issue.

Two weeks ago, Rapid Response requested action on the Medicare Improvements for Patients and Providers Act of 2008. The bill had just passed in the House of Representatives by a wide margin, and had moved on to the Senate for action. This is the bill that contains a number of improvements for Medicare, including help for low-income seniors, better rural and other hospital care, improving outpatient services, improving the Medicare drug benefit program, and enacting a provision that would stop payment cuts to doctors. Thanks to your calls, the bill passed in the Senate yesterday! Senator Ted Kennedy played a key role in the passage of this bill as well. Upon returning to the Senate, he provided the 60 votes needed to secure passage of the bill. When he cast his vote, additional Republicans joined in supporting the bill, however, Senator John McCain was the only Senator not voting on the bill. Senator Obama did vote to support the bill.

Strattec Security

Layoffs

The company is continuing layoffs due to the low orders from Strattec Security Corp. customers, although at a personal meeting on August 13th, the company advised me that orders from GM have increased somewhat, at this writing all layoffs are still voluntary.

Testing

The company has expressed to the union many times that it would like to see our associates advance themselves through job postings and testing if required, but recently, an associate tested for a job long ahead of the job being posted due to retirement, the associate passed the test, then just before the company posted the job, they changed the test and then told the associate that the test they passed was no longer being used. So they must now take the new test, and that the company would not provide study material to the associate. Also, it seems to be a misunderstanding as to when a set-up "B" person is to be advanced pay wise after testing out.

Discharge

The union dealt with one of the most unpleasant subjects. That being a discharge of one of its' union members. At our last membership meeting on August 3rd, our union brothers and sisters from Strattec, based on the facts of the case, voted to uphold the Bargaining Committee's decision and not take a member's grievance to arbitration. The vote was by secret ballot and only Strattec members were allowed to vote on the motion per our by-laws.



Briggs & Stratton Second Shift

At the Falls plant, many of our members feel that they are being harassed by management. Some of the complaints are they are being follow to and from the bath room. One member wrote a grievance because they were written up for going to the bath room after the shift had started. Another member was written up for getting ice one minute after the break had ended. Another member was written up for getting water. At this time the union has receive 18 job complaints from the company. All members were informed that they had the right to write a grievance. The union will take every grievance through the grievance procedure.

Workplace Violence

The company is required to provide a safe work environment. If you have a dispute at work you should contact your steward. The steward will investigate your complaint and if they need to, they will meet with management to resolve the issue. If your steward is not available, please contact your grievance representative. Dean Wegner is the first shift representative. He can be reached at extension 2196 and 6020-2196, if you are calling from the M.F. plant. His pager # is 414-669-6332. If you need to reach me on second shift, my extension is 2197 and 6020-2197 if you are calling from the M.F. plant. My pager # is 414-669-5922.

Dept. 476

July 14, 2008 the company started the 12 hour shifts in Dept. 476, the test house. Some of our members were very upset with this change. However, the company could do it based on the contract language. Some jobs are on 8 hour and some on 12 hour shifts.

Assemblers / Recalled

At this time all assemblers are recalled back to work. The company is in the process of going through the daywork classification to offer them assembly work. The job elimination regarding the assemblers in department 716 Mufflers continue to be pushed back at this time, there is no confirmed date when these jobs will be eliminated. The assemblers in 716 are scheduled to go to department 797 Coils when their job is eliminated. In the mean time, the company is in the hiring mode and they did call back retirees to fill the open jobs. The retirees do not have job preference.

Wellness Corner “You can’t live without it” Start a Regular Exercise Program

Here's Why: Exercise helps keep your body healthy and your tissues and organs working properly. In keeping your body in good working order, exercise also helps ward off many diseases such as heart disease, stroke, type 2 diabetes, osteoporosis, and many others.

Here's How: National health and exercise organizations recommend you do moderately intense physical activity for at least 30 minutes on most (preferably all) days of the week. Doing more vigorous exercise is also encouraged.

Your exercise program should include: Aerobic (Cardiovascular) Exercise In aerobic exercise, you continually move large muscles in the legs and buttocks. This action causes you to breathe more deeply and your heart to work harder to pump blood, thereby strengthening your heart and lungs.

Examples include:

- Walking
- Jogging
- Running
- Aerobic dance
- Bicycling
- Swimming
- Hiking
- Playing sports that involve running, such as basketball and soccer

Strength Training (Resistance Exercise)

Strength training builds lean muscle mass, which increases your physical strength and your bone mass.

Examples include:

- Weight lifting, using:
 - Free weights
 - Weight machines
 - Elastic tubing
 - Calisthenics, such as push ups or chin ups

Flexibility (Stretching) Exercises Stretching increases freedom of movement and improves posture. In addition, it releases muscle tension and soreness, enhances relaxation, and reduces your risk of injury during exercise.

Major muscle groups to stretch include:

- Back muscles
- Neck muscles
- Leg muscles: hamstrings, quadriceps, calf muscles
- Chest muscles
- Buttocks and hip muscles
- Shoulder and arm muscles
- Stomach muscles

Stretching classes include:

- Yoga
- Tai chi

Here are some tips for safe stretching:

- Spend at least 5 to 10 minutes warming up your muscles before stretching. For example, walking gently while swinging your arms in wide circles.
- Start each stretch slowly, exhaling as you gently stretch the muscle.
- Hold each stretch for 10 to 30 seconds.

Here are some common stretching mistakes to avoid:

- Don't bounce during a stretch.
- Don't stretch a muscle that is not warmed up.
- If a stretch hurts, ease up. Don't strain or push a muscle too far.
- Don't hold your breath while stretching.

Getting Started Since brisk walking qualifies as moderately intense physical activity, that's a place to start if you're new to exercise. Before starting an exercise program, check with your doctor about any possible medical problems you may have that would limit your exercise program.

Consider making an appointment with a certified athletic trainer to help you develop a safe, effective, and enjoyable exercise program. You can find a trainer at a local gym or through a referral from your health care provider or a friend. Make sure this person understands your goals and can help you maintain an exercise program that you'll enjoy and stick with.
